GUIDELINES FOR THE USE OF THE HALAL CERTIFICATION MARK

1. Scope of Application

The Halal Certification Mark is permitted for use on:

- Products that have been granted a valid Halal certification.
- Production facilities within the scope of certification.
- Documents, packaging, and labels directly related to Halal products.

2. Usage Instructions for the Halal Mark

2.1 Requirements for Businesses

Company must strictly adhere to the following regulations:

- Use the Halal mark only for the exact products and within the scope stipulated in the certification.
- Do not use the mark in a way that creates confusion regarding the scope of certification.
- Do not edit, alter, or change the shape, color, or content of the Halal mark.
- Do not use the Halal mark once the certification has expired, been suspended, or been revoked.

- Color (Black/white or as specified by the Halal Accreditation Body)

Ensure:

- Clarity and recognizability
- No distortion or deformation

2.3 Placement

The Halal mark is permitted for use on:

- Product packaging
- Product labels
- Catalogues and brochures
- Official websites

Do not place the mark in a manner that:

- Misleads consumers into believing the entire business is Halal-certified (when only a portion is).
- Is in close proximity to content inconsistent with Halal standards.

3. Control Requirements

- Company must maintain a control system to ensure products consistently meet Halal standards.
- Company must be prepared to provide relevant records and documentation upon request for inspection and supervision.
- Company must promptly notify the certification body of any changes related to production, raw materials, or processes.

4. Violations and Sanctions

In the event of a violation regarding the use of the Halal mark:

- The certification body reserves the right to suspend or revoke the certification.
- Company will be required to immediately cease the use of the Halal mark.
- Other measures will be applied in accordance with applicable regulations.
